century didn't deliver Czech and Slovak understandings of state and sovereignty a lot nearer together. Nedelsky concludes that whereas in perform neither the Czechs nor Slovaks deal with yes ethnic minorities (Roma and Hungarians, respectively) as equivalent citizens, the Czechs' civic version of sovereignty bargains safeguards to civil liberties that the Slovaks' ethnic version of sovereignty does not.
